Europe in Labour

God is shaking the nations, and especially Europe right now. The past few years have seen escalating crises. Brexit shattered the unity of the EU, with Britain being the first nation to formally withdraw from the Union. The COVID pandemic brought death and economic chaos, with ruin to many small businesses.

In his book Law and Revolution Harold Berman describes European civilization as founded on Greek rationalism, Roman law, and the Judeo-Christian revelation in the Bible. But he demonstrates that there was not just a synthesis of these three elements. It came as the peoples of the West turned to those sources and transformed and reinterpreted them. The process began in the 11th century for these to lay the foundation for European freedoms, human rights, and the rule of law.


After the trauma of the World Wars, the 20th century saw two moments when there was hope that many of the horrors of Europe's history would only be a memory of a darker past. The first was the victory over fascism in 1945, and the founding of the United Nations. In the wake of the Holocaust the nations said never again. Within the following years the seeds were sown with the hope of a united

Europe, leading to the European Union. Shortly thereafter followed the end of the European colonial empires and the emergence of the global south, or the "majority world."


The second was the fall of the Berlin Wall in 1989 and the subsequent dissolution of the Soviet empire in eastern Europe as many nations, including Ukraine, regained independence after many years of Russian and Soviet rule. Liberal democracy had triumphed.

The fear of nuclear annihilation that had hung over humanity for so long seemed to be past. It seemed the Cold War was over. There would be local conflicts in the Balkans and Russia in Georgia and Crimea, but nothing that was broader. But the peace of Europe was shattered on 25 February when Russia launched a full scale invasion of Ukraine, starting the largest war in Europe since World War 2.As I write this the Russian army is closing in on Kyiv, capital of a free and independent Ukraine. Whole cities such as Mariupol lie in ruins.

With so much hope at the close of the 20th century, how did we get to where we are today?

- I We did not adequately deal with the legacy of colonialism, in the Middle East and Africa particularly. Colonial borders had been drawn to suit European interests. After independence these contributed to the instability in these nations. Colonialism had undermined traditional leadership, and left bureaucratic states in its wake. This instability has contributed significantly to the threat of terrorism and the refugee crisis.
- 2 Western nations failed to help Russia truly transition away from communism, which did happen in many other post-communist countries in eastern and central Europe. In Russia many of 6 - Some roots of the Ukrainian war the same people and much of the security apparatus from the old Soviet days remained in place, waiting to reassert themselves.
- 3 In 1648 the Peace of Westphalia and the revolutionary movements of the 18th and 19th centuries had established that each nation was sovereign over what actions it took within its own borders. The United Nations was still founded on this idea of sovereignty which limited its ability to be effective in the world. Much of the rhetoric around Brexit related to the issue of national sovereignty.

- 4 While the European Union was initiated by a group of Christian Catholic statesmen, desiring to see a united Europe founded on Christian values, in subsequent years the European project drifted away from this vision. There has been a failure to articulate the foundation of 'European' values such as democracy, human rights and the rule of law, because those arose from a biblical foundation. With the widespread loss of biblical faith, there was no solid foundation for these values.
- 5 Protestants in much of Europe, especially evangelicals holding to a pessimistic eschatology, have in large measure withdrawn from the public
- go back much further, to the Great Schism of 1054 between the Eastern Church and the Western Church. Western Ukraine contains many Roman Catholics who look to Rome; Eastern is largely Orthodox and has looked historically to Moscow. Reconciliation between Christians will be key in bringing a true peace.

As we see the nations shaking it is important that we look to what God is doing. His purposes are to see His unshakeable kingdom come, in Europe, and in the world.

Refugees and their impact in Europe

Refugees are not a new phenomenon on European soil. The latest wave of refugees has just been created in Europe and on the borders of the European Union. The last wave of refugees that had a major impact on European life began in the Middle East just ten years earlier, during the chaos of the Arab Spring.

Refugees have been arriving in Europe for several decades. We remember the boat refugees that arrived to multiple European countries from Vietnam and their neighbouring countries in the mid-1970s. Many also recall the refugees that arrived from Chile. The majority of them have adapted to European life. For several years now, refugees have also been arriving in Europe from various African countries across the Mediterranean. Thousands of lives have been lost due to the turbulent sea.

Why are there so many refugees year after year?

There is no simple answer to this guestion: people leave in search of a safer and better life, either voluntarily or involuntarily. They often leave because of a crisis, such as famine or armed conflict, but religious and political persecution is also a frequent reason. The idea of a European paradise increases Europe's appeal.

In the last ten years, the number of refugees in the world has doubled from 40 million to more than 80 million.

The arrival of refugees in Europe is not simple and often requires great efforts, not only during the difficult journey, but also in the process of applying for asylum, learning a new language and culture, and finding a place to study or work. Europe as a whole is facing increasing labour shortages, but the education of refugees does not often meet European standards and requires

reform the asylum application system and increase solidarity between EU member states, particularly between southern and northern European countries. This is because the arrival of large numbers of refugees in southern Europe has strained relations between southern Europe and other EU countries.

The current acute refugee crisis has already brought more than 4 million Ukrainian refugees to various European countries in the space of a few months. They have been granted immediate work and residence permits because of a special agreement. This has, in turn, caused a negative reaction among those who have already applied for asylum, as it has postponed the decision which they have sometimes been expecting

The arrival of Ukrainian refugees in Western and Northern Europe has led various Christian churches and missionary organisations to cooperate more closely in helping refugees. The same has taken place between spiritual and humanitarian organisations such as the Red Cross and the UN Refugee Agency (UNCHR and IOM).

The Greatest Epidemic

What if, Covid-19 wasn't as deadly as we were told? What if, national deaths and infection rates were overstated and based in unreliable testing? What if, yesterday's conspiracy theories are today's emerging truth? And what if, our children had the answers? BY HELEN BARRIOS

Perhaps you feel uncomfortable, indignant, or defiant in front of these questions. Well, it's good to think and to feel, it makes us who we are - it makes us human. It drives us to love, protect and search for connection, and it allows us to feel fear and anxiety.

On the 23rd of March 2020 the UK entered into the first lockdown, with many other European countries already closing their borders, restricting travel, and limiting social interaction. Anxiety propelled Europe as fear dominated our headlines.

So, what happens in the human brain when faced with crisis?

It is scientifically proven that when a human brain faces crisis or experiences heightened levels of stress, fear or anxiety the brain begins to shut down and enters into survival mode. It is also proven that the strongest and most powerful emotion humans can feel is fear. Meredith Moore, Founder and CEO Greylake Training Solutions (I) explains "how in milliseconds our brains release hormones that produce a biological reaction - freeze, fight or flight ... our vision narrows and produces a tunnel effect so we can hone in on the only thing that matters, the dangerous situation.

Place this response, onto the global stage, where, like actors, we found ourselves fighting against an unknown, unpredictable, and deadly monster. which could contaminate and kill us at any time.

Let's look back at history. At any pivotal

or a national disaster, whenever crisis hits, we look for 'heroes.' Someone to guide us, someone to give us answers and someone to offer security. In these situations, we do not naturally question their message or their underlining philosophy or goals, but rather our intense need for a 'saviour' drives blindly forward.

CERC: Psychology of a Crisis explains how "Under intense stress and possible information overload, we tend to ...

- Not fully hear information because of our inability to juggle multiple facts during a crisis. - Not remember as much of the information as we normal-
- Misinterpret confusing action messages. Instead, we may rely on habits and longheld practices. We might follow bad examples set by others." (2)

We often see, what is nominated as, 'herding behaviour'."Herding behaviour refers to how individual decisions are influenced by group behaviour." (3)

This behaviour is based on the premise that the rest of the group has done their research and made an educated, independent decision. However, this decision-making process is more often based on whatever information is presented first and most frequently by socially accepted influencers.

This does not underestimate the intelligence of each individual but rather places the emphasis on the ability and willingness to think critically, overcome feelings of fear and anxiety, and look Against this backdrop, how did we beyond. When people are afraid, they make irrational decisions. A "populace that stops thinking for itself is point, whether this be in war, genocide, a populace that is easily led, easily manipulated and easily controlled." (4)


So during the pandemic, what was the central message the general **bublic heard?**

In this state of emergency, it is common practise that governments seek to increase their state of power, using any methods available to do so. Employing persuasive tactics that coincidentally, provoke more fear, anxiety, and stress, maintaining society in a constant state of high alert, tunnel vision and adversely impacts decision-making.

The mainstream media bombarded our screens, with images of sick people on ventilators, hospitals on the brink of collapse and empty streets, whilst proven marketing strategies and propaganda strategies were employed, reinforced political agendas.

On the 28th of August 2020, during a press conference the Children's Health Defense, led by Robert F. Kennedy Jr. discussed how governments use fear to control and manipulate the population. "Point a finger at that source of their fear and you can make human beings do anything you want. You can make them go to the slaughter like sheep; you can make them obey." (5)

Media censorship throughout the world increased under the premise of the people's greatest good. Amnesty International states that "Freedom of expression is under attack and it's affecting our ability to end the pandemic... Silenced and Misinformed: Freedom of Expression in Danger During Covid-19 reveals how the limiting of freedom of expression as well as the ramping up of punishment throughout the crisis has significantly reduced the quality of information reaching populations around the world." (7) Here in the UK, journalists who question the governments mandates are silenced and political correspondence rejected from daily Covid Press briefings, whilst those who stand alongside the government are welcomed to question, their programmes aired freely and news broadcasts continuously promote their ideals. Open Democracy reports that "these incidents are part of a long-growing climate of hostility to journalism here in the UK, emanating right from the top of Boris Johnson's Downing Street."

Last month a report by the research charity Collateral Global and academics at Oxford University concluded as much, stating that as many as one third of all positive cases may not have been infectious. If they are right, that's a potentially staggering number – roughly six million cases ... Professor François Balloux, director of University College London's Genetics Institute, told The Mail on Sunday: 'Many people may not have been infectious, despite getting a Like previous generations, exposed to positive test.' (10)

In other words approximately 6 million people, not to mention additional family and contacts who may have been 'pinged' could have had their lives negatively impacted by unnecessarily isolating, potentially losing income and missing weeks of education. This so called unquestionable 'golden standard' that established national infection rates and paved the way for the whole country, is today, the centre of investigation.

Yes, obviously we should take steps to prevent harm, danger and protect the most vulnerable, but what happens tic abuse crimes. when the information we receive is marred?

How can we then formulate, approve or act on the most suitable plan of prevention?

And who defines the most vulnerable? Is it those whose health could be compromised if they are infected or is it the victims of domestic abuse who were legally bound to stay at home for months with their abuser?

Thankfully, a clear example of where human rights has been protected was when the jobs of the very NHS workers, we rightfully applauded a year earlier, was placed in jeopardy with the government's proposed mandatory vaccine plan in January 2022, potentially losing 73,000 NHS workers and provoking a national staff shortage. (11) Here we saw the public question the potential acts of the government and rise up to question it.

But what are the long-term impacts of the pandemic?

Whilst these ideas may provoke more questions, I believe, there is one strong idea that prevails, fear is the greatest and most dangerous disease, paralysing critical thinking and numbing our response. Above all I would propose the question: how are we going to overcome this epidemic?

disasters, war and dictatorships, this generation can now vividly remember when the schools closed, parents lost their jobs, and they weren't allowed to say 'goodbye' to loved ones who had passed away. Today, in the 21st century we repeatedly find ourselves deliberating over civil and human rights, facing economic instability and considering the long-term mental health implications.



What Works Wellbeing reports that "the group reporting the highest levels of loneliness in the UK is young people." (17) Experience shows that children suffering from mental health problems at an early age are more likely to suffer from long term mental illnesses, unless they access early intervention. "Alarmingly, however, 75% of children and young people who experience a mental health problem aren't getting the help they need." (18)

But how can we respond in this moment of crisis where authorities are denying information, condescendingly taking actions against their own regulations, and enforcing a mentality of fear and isolation, regardless of the long-term consequences?

Hannah Barrios responded and she wrote a book. At the age of II, faced with even more restrictions in her last year at Primary School; Hannah put pen to paper. Hannah loves writing but not quite as much as she loves hanging out with her friends and family. She is essentially a true representative of a generation of children who had their formal education disrupted and unexpectedly had their mental health challenged in a way recent generations had not experienced. But Hannah did not stay in a position of fear, but rather found a positive way to think of others and wrote her first book 'Everyone Can Shine'.

Hannah's book is aimed at 4 - 7-yearolds and promotes children's mental health, exploring ideas around friends, feelings, and self-worth. Through the two main characters unlikely friendship, Autumn and Sprocket discover how empathy and understanding can build resilience and help deal with negative comments, which in turn enables Autumn to rediscover her true colours.

Hannah, together with her family ran a crowdfunding campaign to publish her book and raised a staggering £4000, in additional to a local government grant reaching a total of £5000. Through givers generosity Hannah has given away over 800 books, shared with over 700 pupils in local primary schools, and aims to give every Primary School in her borough a free copy of her book.


The response to her book has been outstanding, as Heads, Deputy Heads and Year Group Leads praised her for communicating "some real pearls of wisdom and a vital message that is suitable for all." The book supports the Key Stage 2 PSHE National Curriculum and has been recommended as it "covers many issues in a sensitive way and is a must for every teacher and parent."

Hannah now intends to focus on the remaining books in her new book series, whilst publishing a children's activity book and a set of 'Affirmation and Emotion Postcards' that offer advice and practical suggestions for children to explore, manage and express their

So hope is not lost, and fear does not have to take hold. Perhaps we should consider the simple responses of this younger generation, who regardless of position, fear or rejection reach out to others, offer solutions and declare a message of simple truth that cannot be shaken.

Ushat makes governing so difficult?

A CHRISTIAN WHO HAS WORKED IN CENTRAL AND LOCAL GOVERNMENT

"Events, dear boy, events." British Prime Minister Harold MacMillan

When asked what makes governing so difficult, British Prime Minister Harold MacMillan replied "Events, dear boy, events". He was right. The same is true for most leaders and most organisations. And most of us. too. At its simplest, whether predicted or

not, whether rehearsed or not, whether localised or not, or whether a human failing or a natural disaster, events make governing more difficult. Responding to "an event" of whatever type is difficult and will typically require much time, resources and effort, but trying to resolve the underlying issues that gave rise to the event may take much longer. Few will forget the Grenfell fire tragedy of 14th July 2017: the initial response by the voluntary sector, the local authority and central government lasted weeks. The recovery has taken almost five years, and the community is still deeply affected by it. The initial phases of the Inquiry have been very revealing about the reasons: the combined evidence points to a grave failure of the entire British state over a prolonged period, and will take significant resources, much determination and years fully to rectify.

Few individuals or institutions who have given evidence have come out with their reputations enhanced. Amongst other things, the Grenfell Inquiry has shown ... greed, weakness, incompetence, complacency, a low value placed on safety and of life, and ultimately indeed of the fallenness of man.

Human beings are complex. So are institutions. And the bigger they get, the more complex they become. Further, since the end of WW2 in particular, the role of governments has increased greatly - doing much that used to be done by the voluntary and community sectors and churches. From a Biblical perspective, while some of government's increased remit has been benign, much has been more questionable, particularly when coupled with a strongly humanistic attitude of the government claiming to be able to solve many if not most social problems - while rejecting the key Biblical notion that man by nature is fallen, and hence a sinner. Christians must be realistic about human nature.



Globally, things are getting more challengwe are in the last days. We have been in the last days since lesus was crucified and resurrected. But now, much prophecy has been fulfilled, notably the existence of Israel as a country, and the presence in that country of Jewish believers in Jesus (Yeshua); the spread increasing persecution and discrimination of believers globally - and the wars, rumours of war, plagues, pestilences and earthquakes.

Hard heads are needed to help steer nations - and church fellowships. A strong Biblical faith is essential - and we must pray even more. Perhaps a key reason whey Christians have in might have been when in office is that some have settled for too little, while others have pursued their own agendas, not God's. I wonder if too many have preferred to sit at the government's table, rather than alone with the King. 

EVERY DAY I HEAR THE SAME QUESTION ...
WHY IS THIS WAR HAPPENING IN UKRAINE?





Every one of us can identify with an event in our lives that has impacted us in such a way that there is a distinctive divide; there is a definite before and after and life will never be the same again. On the 24th of February 2022 at 5am this kind of event happened in my life, as well as in the lives of 40 million Ukrainians.

From that morning on my life has become almost surreal, every morning I wake up with hope that everything that is happening in Ukraine is just a nightmare, but unfortunately war is real.

The actual war, started by Russia, did not begin in February 2022 but rather spring 2014 with the annexation of Crimea and the war that followed in the Donbas region. For a fleeting moment, Ukraine became a hotspot for world attention, but after just a few short weeks headlines changed and Ukraine disappeared into the background as the world returned to business as usual. Nevertheless, in the past eight years Ukraine has lost 150,000 people, over 50,000 people have been wounded, 2 million people have been displaced and our nation has last 7% of its territory.

Repeatedly, throughout these years we have tried to communicate to the world politicians that there was danger coming and not just for our nation but to the world. However, powerful people of today, including the UN, turned their deaf ear and ignored us.

Today, we face the results of this ignorance, where money and business have more value than human life, empathy, and compassion.

Every day I hear the same question - why is this war happening in Ukraine? Of course, there are many answers and opinions to that question, and these are just a few of my personal subjective thoughts...

Firstly, we are living in a sinful world where greed and power have the greatest value and Satan is operating in his "gifts" to the fullest. Secondly, throughout history we can see the rise and fall of endless empires and Russia is no exception.

Some years ago, President Putin stated that the fall of the Soviet Union was the biggest geopolitical catastrophe of the 20th century. What we are witnessing today is the desire to turn back time, to regain power and influence over territory they lost, and become a world superpower once again.

When you study Ukrainian history, it is marred with fights, battles, and wars. Geographically, Ukraine is the dividing point between Western and Eastern civilization. Unfortunately, almost of all of these conflicts have passed through our land, many times leaving our country occupied by other nations. My grandfather lived to the age of 92, and unbelievably lived in seven different countries in the same house. However, in Ukraine, this is just a small example of complexity of our life, and yet, **WE NEVER STOP DREAMING.** We dream of having a free and independent Ukraine.



In August 1991, with the fall of Soviet Union, we felt the prayers of many generations had been answered. From that moment, until recently, we experienced the longest period of independence in the history of our nation, marking the first independence in the last 550 years. However, over the past 30 years I have lived with the feeling that one day Russia will come back and will do something to take Ukraine back under its control. So what happened in 2014, with the war on the Eastern side, and now with the full invasion, did not surprise me at all.

Every day I stand being surrendered by the pain and suffering; and am amazed by what God is doing amid all the tragedy. We see unprecedented unity in the Body of Christ, in our city, Ternopil. We started a joint relief effort together with of all 32 Evangelical and Protestant churches, we opened 23 shelters for refugees where we can host up to 3500 refugees per night and from the second day of the war, we started evacuation from the most difficult places into Western Ukraine as well as evacuating people to European nations. (approx.10000+ refugees) We have coordinated a flow of humanitarian aid to the front lines with over 400 tons of supplies being provided through our operation, not to mention assisting others doing similar work. The support and care we receive from our YWAM family and so many different churches and organizations around the world has been overwhelming. We loved, we cared, and we are together moving forward to the victory day.

And allow me to conclude by sharing my thoughts concerning the war in Ukraine and God's Sovereignty to end a season of postmodernism.

For a long time, we were in living in the world of relative truth and tolerance, our Christianity has become personal, cultural and in many ways nominal. God challenged this status quo firstly, through the two years of Covid-19 and now through the war. Through these events we can now see clearly again, differentiating between good and evil and being able to define what is the real truth. In these days the whole world, including the Body of Christ, is experiencing an unprecedented awakening, and this is what gives me hope. I truly believe there is a future for this world.

"My fellow believers, when it seems as though you are facing nothing but difficulties, see it as an invaluable opportunity to experience the greatest joy that you can! For you know that when your faith is tested it stirs up in you the power of endurance.

And then as your endurance grows even stronger, it will release perfection into every part of your being until there is nothing missing and nothing lacking."

God is in the move, and we need to join Him in His mission.



IN EUROPE



When perception and reality clash -the underlining truth

Religious persecution and discrimination are well-documented global realities.

However, when these topics arises most of our thoughts, as Europeans, fly to the terrible ISIS persecution of Christians in the Middle-East, or the Hindu persecution against Muslims and Christians in India or the vicious kidnapping of young non-Muslim girls by Boko Haram in Nigeria.

However, very few of us would associate Europe with religious persecution and discrimination. Europeans tend to see themselves as positively tolerant, embracing diverse opinions, cultures, and lifestyles. However, when we look at data and, in some cases, headlines closer to home, we find that the image Europe has of itself does not always reflect reality.

In 2011, at the opening session of the OSCE high-level meeting on Anti-Christian Violence in Rome, Metropolitan Hilarion of Volokolamsk, addressed the delegates of various European religious organisations

regarding "the violation of the rights of Christians and respond to this challenge through our common efforts."

One statement, in particular, stood out as extremely relevant:

"I am convinced that society, which has renounced its spiritual heritage under the pretext of the radical separation of religious life from public life, becomes vulnerable to the spirit of enmity in relation to representatives of any religion. This indeed does create an atmosphere of intolerance concerning Christians and representatives of other traditional religions. This statement can be proven by many examples."

Indeed, Metropolitan Hilarion was right then and has been proven right in the years after his address in Rome up to the present day. It is clear to evident to see various statistics, policies and incidents show that religious discrimination and even violent persecution in Europe do occur, probably more than we are willing and comfortable to admit.

Judaism

- in 2020 there were 2,224 anti-Semitic offences reported to police in Germany which could be classified under rightwing crime.
- Survey results indicate that as of 2018, Jewish people in the Netherlands found anti-lewish sentiment to have a high prevalence in Dutch society. Over 75 per cent of Jewish people surveyed indicated that according to them, there was a lot or quite a lot of anti-Jewish sentiment in the Netherlands, whilst roughly a fifth of respondents did not consider anti-lewish sentiments to be very common.
- In 2019, the first of the answers given by the lews of France when they were asked what were, according to them, the causes of anti-Semitism, was Islamism. Another 42 per cent saw anti-Semitism that have existed for centuries and are still present today. In addition, more than a quarter of them (26 %) found the cause of this phenomenon in extreme right-wing ideas and ideas conveyed on the Internet and social networks.
- Over 1.6 thousand anti-Semitic incidents were reported to the Community Security Trust in the United Kingdom in 2020, the most of any year in the provided time period. There has been a clear and noticeable increase in the number of anti-Semitic incidents reported in the UK since 2013 when just 535 incidents were reported.

• Among the 234 anti-Muslim incidents recorded by the French Ministry of the Interior and the National Advisory Commission on Human Rights in France in 2020, 43% were anti-Muslim inscriptions. The next two most frequent types of aggression towards Muslims were threatening words and gestures (23%), and leaflets and letters (20%).

Christianity

- In 2019, more than half of the anti-religious acts identified by the French Ministry of the Interior concerned the Christian community. According to the source, these were mainly attacks on religious property. The second most affected community was the Jewish community in France (36.29% of anti-religious acts). It is also interesting to note that in the following year, 2020, the number of anti-Semitic acts was half the number recorded in 2019.
- According to statistics, it appears that Christian places of worship in France were the most targeted sites with 949 acts of vandalism in 2016 and 878 in 2017. The survey reveals that acts of vandalism against all kinds of places of worship decreased in France from 2016 to 2017 except for lewish religious sites: as resulting from prejudices about Jews In 2017, 28 acts of vandalism against lewish places of worship were counted, compared to 23 in 2016.
 - As recently as 2020 there were attacks on churches in the German town of Tuebingen perpetrated by a radical feminist group who vandalized two Christian churches in Germany and burned the car of a pro-life journalist.
 - There have been steady reports of cases of persecution of Christians who criticize social evils, for example, clergy and lay believers who criticize homosexuality as sinful often face public ostracism and severe discrimination. The case that comes to mind is the one of a Spanish Archbishop, who reaffirmed Roman Catholic Church teaching held for centuries and was prosecuted for it. Christians are also consistently attacked because of their position on Euthanasia and Abortion.

There have been many more instances and cases all over Europe, although they will rarely make headlines and one has to be willing to dig and search to find them. The understanding of our reality as it is and not as we want it to be is imperative for all human beings as it allows us realise where we truly are and what we can do to change our circumstances. Many people in Europe do not care overly much about religion but they definitely do care about their rights of freedom of thought and freedom of beliefs. If we do not preserve these rights for all, regardless of religion there is no saying what the future might hold.
